ADVERTISEMENT FOR FILLING UP VACANCIES ON DEPUTATION BASIS

The All-India Council for Technical Education (AICTE) invites online applications in the prescribed proforma from the well qualified and experienced employees of Central/ State Governments/Universities/Autonomous Bodies/PSUs for filling up the vacancies to the posts of Director, Deputy Director & Assistant Director on deputation basis. AICTE was established by an Act of Parliament (No.52 of 1987) with a view to proper planning and coordinated development of the technical education system throughout the country, the promotion of qualitative improvements of such education in relation to planned quantitative growth and the regulation and proper maintenance of norms and standards in the technical education system and for matters connected therewith.

The appointment on **deputation basis will be** initially for a period of three years and thereafter on yearly basis in terms of DoPT orders on the subject. The selected candidates are liable to be posted at AICTE New Delhi or at any of its Regional Coordination Centres/Regional Indovation Centres AICTE across India. GENERAL TERMS AND CONDITIONS

1. Number of posts are tentative, may vary and the Council reserves the right to increase or decrease the number of posts and may or may not fill any post(s).
2. The prescribed qualifications are the minimum and mere possession and fulfillment of the essential and desirable qualifications for a post does not entitle the candidate to be called for interview.
3. Interested candidates may apply online in AICTE Web portal www.aicte-india.org on or before **01.12.2023**. Proforma for applying online will be available on the AICTE website **w.e.f. 16.11.2023**. A printout of the duly filled-in and submitted application should be downloaded from the portal. The downloaded application should be signed and affixed with self-photograph (passport size).
4. The application has to be forwarded by the present employer along with the requisite self-attested supporting documents so as to reach AICTE, New Delhi on or before **01.12.2023**. The envelope containing application should be super-scribed with "APPLICATION FOR THE POST OF DIRECTOR/DEPUTY DIRECTOR/ASSISTANT DIRECTOR" and advertisement number.
5. The candidates short-listed for interview will be informed by e-mail and/or by Post. The Council will not be responsible for any postal delay.
6. Original Educational Qualification, Experience and Caste certificate, etc. should be produced only at the time of interview. However, self-attested photocopies of testimonials may also be uploaded with the application in support of their educational qualifications and experience etc.
7. Applications received through proper channel will only be considered for final shortlisting for the selection process. Candidates need not send the advance copy of the application.
8. It shall be necessary to furnish original, Annexure-II "**Part-D/No Objection Certificate**" from the parent department/ present employer at the time of interview. They should also upload the same with the online application if made available at the time of applying.
9. The decision of the Council in respect of selections shall be final and no correspondence in this regard will be entertained. Canvassing in any type from any source will disqualify the candidature of the applicant.
10. All guidelines regarding deputation as issued by DoPT for autonomous bodies from time to time shall be applicable.
11. *Candidates working in Institutions/Universities/Organizations which are funded by private resources are not eligible to apply for these posts. Tenure of candidates served in Private Institutions/Universities/Organizations will not be counted as part of experience as prescribed in the "Educational Qualifications and Experience prescribed for the post" mentioned above.*
12. The terms and conditions of deputation will be regulated in accordance with the Department of Personnel & Training O.M. No.6/8/2009-Estt.(Pay) dated 17th June 2010 and O.M. No.2/6/2016-Estt.(Pay-II) dated 17.02.2016, as amended from time to time. *A person in higher Grade Pay shall not be eligible for appointment to a post carrying a lower Grade Pay.*
13. The pay scale/grade pay of regular post would only be taken into account for deciding the eligibility for appointment/ selection to a higher post on deputation basis. Pay scale and grade pay received on financial up-gradation under ACP/MACP will not be considered for deputation.
14. The candidates are required to bring the following documents at the time of interview in sealed cover, otherwise they will not be entertained to attend the interview:

15. The **maximum age limit for appointment by deputation shall not exceed 56 years** as on the closing date of the receipt of application.
