




**OFFICE MEMORANDUM**

India International Institute of Democracy and Election Management (IIIDEM) has been established by the Election Commission of India (ECI) *inter alia* to train, prepare and equip election officials and other stake holders for delivery of free, fair and credible and error free elections. It also aims at sensitization, motivation and preparation of the machinery as well as the stake holders of the international democratic community and helping them in overcoming shortcomings and challenges of election management.

2. The Election Commission of India (ECI) invites applications for T.N.Seshan Chair at the IIIDEM i.e. Professor, at Academic level 14, in the scale of pay Rs.1,44,200-2,18,200. The appointment will be on deputation basis from Universities, Organizations or Institutions under the administrative control of the Govt. of India.

3. The period of deputation, including the period of deputation to another ex-cadre post held immediately preceding this appointment in any other organization or department of the Govt. of India or State Govt. shall not exceed 5 (five) years. The pay, allowances and other terms of conditions of the officer selected for such appointment shall be regulated in terms of extant guidelines issued by the University Grants Commission (UGC) and Department of Personnel & Training (DoP&T) from time to time.
