S.No.	Question	Response
1.	Nature of appointment	Appointment will be on deputation basis in terms of DoP&T OM No. 6/8/2009-Estt. (Pay-II) Dt 17.06.2010 <sup>[1]</sup> as amended from time to time.
2.	Residential accommodation	<ul style="list-style-type: none"> <li>• There will be no eligibility for allotment of General Pool residential accommodation.</li> <li>• However, HRA will be admissible as per applicable rates.</li> <li>• The IIIDEM is covered within the meaning of 'newly created autonomous body' under the administrative control of the ECI. Therefore, it may be possible for the person so selected to approach his parent office and Directorate of Estate for retention of his existing accommodation, up to 60 months in terms of M/o UD OM No. 12035/13/2013 Pol II, Dt. 09.07.14</li> </ul>
3.	Staff Car	Facility of Air-conditioned Staff Car, will be available in terms of M/o Finance O.M. No. 3(1)/E.II(A) 2009 Dt. 30.06.2009 <sup>[2]</sup>
4.	Telephone Facility	Telephone facility in office and reimbursement of telephone call charges of residential telephone/Mobile phone/ broadband etc will be available in terms of O.M. No. 24(3)/E Coord/2018 Dt. 26.03.2018 <sup>[3]</sup>
5.	Medical facilities	In case the officer is already in receipt of benefits under the CGHS, he will be entitled to continue to avail such benefits. In all other cases, the officer so selected will be allowed the option for continuation of facility in his parent office or to avail the benefits under Civil Services (MA) Rules
6.	Secretarial assistance	Will be available at the same level as available to an officer of the rank of Jt. Secy in the Govt. of India.

7.	Deputation Duty allowance	Deputation Duty Allowance will be admissible at the rates as prescribed in O.M. No. 2/11/2017-Estt (Pay-II) Dt. 24.11.2017 <sup>[4]</sup>
8.	Other allowances and benefits	Other allowances like L.T.C and Children's Education Allowance etc will be admissible as per instructions issued by the DoP&T from time to time.
9.	Special Allowance in parent office	Any special allowance granted by the parent office under FR 9(25) etc shall not be admissible
10.	Personal pay granted by the parent office	Personal pay, if any, drawn by an employee in his parent department will continue to be admissible, if he opts to draw pay in the parent cadre scale plus deputation duty allowance. No deputation duty allowance will be admissible on personal pay.
11.	Leave salary / Pension/ NPS contribution	In terms of DoP&T OM No 6/8/2009 Estt (Pay-II) Dt. 15.02.2012 <sup>[5]</sup> , allocation of leave salary and pension contribution between different Ministries/ Departments and between Central and State Govts, has been dispensed with. However, in case of deputation from an Autonomous body to IIIDEM, in case of need, IIIDEM will bear the expenditure on such contribution. The IIIDEM shall also make matching contribution to the NPS account, in case of need.
12.	Logistic support to the Chair	Funding of the chair including books and journals, contingency, travel (Local & National) and organization of workshop etc will be admissible as per UGC instructions No. 1-2/2019 (chairs) issued in December 2019 <sup>[6]</sup> .
